Identification of Beneficiaries for 30 MW Solar Rooftop Project in South Andaman

The Electricity Department, in coordination with the District Administration, South Andaman, hereby informs the general public that a **beneficiary identification drive** is being undertaken as part of the implementation of the **30 MW Solar Rooftop Project in RESCO Mode** under the **Utility led Aggregation (ULA) Model** of the **PM Surya Ghar: Muft Bijli Yojana (PMSG-MBY)**.

This ambitious project is aimed at promoting clean energy and providing relief to the **weaker sections of society** through the installation of solar rooftop systems.
